Integral Faculty Development
Progress report for CETYS' Faculty Certification Program

During 2010, the Center for Academic Development and Improvement (CADI), through the coordination of Integral Faculty Development (FIP in Spanish), continued implementing actions directed towards the promotion of faculty's development and training in pedagogical, technological, values and cultural competencies. This purpose is fulfilled through CETYS' Faculty Certification Program (CDC in Spanish), which included a total of 14 courses offered to all faculty members. Information regarding each course is detailed below:

It is important to notice that, in 2009, the amount invested in faculty formation was \$434,590.57 pesos, which covered the instructor fees & travel, cafeteria and printed materials.

Also, in accordance with the program's purposes, all courses and workshops are part of a specific formation line, so participants may accumulate hour of training that result in expected competency levels for each of them. Following this rationale, individual faculty's routes are tracked to see their progress and level of certification achieved. The following describes the general progress of the program, according to statistics reviewed in April, 2011:
